TASK FORCE UNVEILS CODE OF ETHICS

The Sales Integrity Task Force, a 22-person panel formed at the request of the Thoroughbred Owners and Breeders Association to address issues of ethics and communication at Thoroughbred auctions, unveiled a Code of Ethics at a press conference yesterday. "Our mission was to examine practices and make recommendations where they were warranted," explained Task Force Chairman Cot Campbell. "The Task Force took a tough, but realistic stance. We especially sought to protect new buyers, recognizing that the horse auction scene can be intimidating and confusing to novices. We stressed that buyers need to exercise their own due diligence prior to buying a horse, as would be the case in reaching any other business decision."

Under the Code...

One of the key points covered by the Code is the practice of using medical procedures to alter the conformation of prospective sales horses. Under the Code, surgeries that are expected to result in permanent conformation changes can be performed, but must be disclosed. Any procedure designed to temporarily alter the horse's conformation is banned. A second article addresses the issue of ownership. While the Code will not require consignors to supply ownership information, "all sales companies are requested to encourage consignors and consigning agents to reveal all information about ownership which a prospective buyer or buyer's agent might seek, both on the catalogue page and verbally." Veterinarians utilizing a sale's repository will be required to sign a legal form that will disclose any ownership of horses in the sale, and if anyone employed by or affiliated with the sales company has an interest in one of the sales horses, that information must be included on the catalogue page. Any change in ownership that occurs once the horse has arrived on the sales grounds is required to be announced from the auctioneer's stand prior to the sale. **Code cont. p2**

STARS OUT IN HOLLYWOOD

The GI Hollywood Futurity hasn't fielded the Eclipse Award winner for champion two-year-old since Roving Boy took the title in 1982, but that just might change Saturday afternoon when three bona fide contenders enter the starting gate. Unbeaten **Declan's Moon** (Malibu Moon) will face off with GI Breeders' Cup Juvenile hero **Wilko** (Awesome Again) and GI Champagne S. victor **Proud Accolade** (Yes It's True), whose perfect record ended in the Breeders' Cup. That triumvirate will be joined by British import **General Jumbo (GB)** (Dansili {GB}), who has been flown in by trainer Brian Meehan. Second by a neck over heavy ground in his career opener at Newbury Oct. 23, the bay handled the all-weather surface at Lingfield with aplomb Nov. 13, graduating from the maiden ranks with a five-length tally going a mile. Kentuckians Jack Smith III and Tom Conway purchased the big colt privately following his maiden win, and Meehan opted to wait until this race before shipping over. "We thought about the Remsen [Nov. 27], but that was too soon," Meehan explained. "This made more sense. It gave us more time." It will be the last time Meehan saddles General Jumbo, who will join Niall O'Callaghan's barn following the Futurity.

The Role of Agent...

The Task Force has recommended that any prospective buyer working with a bloodstock agent enter into a written agreement with that agent. The agreement drafted by the Task Force is available from the TOBA offices. The Code also branded dual agency, whereby an agent receives commissions from both the buyer and the seller of any horse, without disclosure, a fraudulent practice, and "implores sales companies to print prominently in all sale catalogues the relevant state statute relating to dual agency." Also defined as fraudulent was the practice of establishing a "secret price" for a horse, then, if the horse sells for more than that price, dividing the profits between the seller and the agent representing the buyer.

The Responsibility of the Sales Company...

The major sales companies have already signed off on the Code of Ethics, and have agreed to display an outline of the key points in the barn area on the sales grounds. TOBA will assist the sales companies with this measure. It has also been requested that sales companies distribute relevant information, to be made available by TOBA, that will "promote the understanding of the various dynamics of the auction market and to protect equally the interests of all parties involved."

Going Forward...

To some degree, the Code of Ethics mirrors the British Code of Practices that was established earlier this year. Cot Campbell believes it will have a lasting effect on the American Thoroughbred market. "We understand that the British Code of Practices, adopted in early summer, has been most effective in addressing questionable auction practices," he said. "While we do not have a governing body such as the British Jockey Club, our Code is far more comprehensive, and we are optimistic that it will help level the playing field on the American auction scene." Campbell will step down as chairman in January of 2005, but he has established a three-person Monitoring Committee to oversee the progress of the Task Force and to make any changes necessary in procedure. The Committee, consisting of Chairman Reynolds Bell, Jr., Satish Sanan and Fred Seitz, will serve from Jan. 15, 2005 into 2006. SMITH TO LAUNCH "FRIENDS OF NY RACING"

Tim Smith, the former commissioner of the National Thoroughbred Racing Association, yesterday announced the creation of "Friends of New York Racing," a non-profit organization with the goal of analyzing the structure and economics of New York racing and designing a new business model for the industry in the state. Smith will head the group, which was founded by Breeders' Cup, Churchill Downs Inc., Magna Entertainment Corp., The Jockey Club, the Keeneland Association, the Oak Tree Racing Association, Scientific Games Corporation and Woodbine Entertainment Group. With an operating budget of approximately \$1 million provided by the founders, the FNYR will be launched early next year. One of its main goals will be to bring New York racing into the 21st century. "The basic business structure and underlying legislation for New York racing and wagering was created in the 1950s," Smith explained. "The gaming universe, the competitive environment, the relevant technology, the economics of horse racing and the fiscal needs of state and local governments each has changed greatly since then. Friends of New York Racing will look at ways to modernize and improve the racing business to help ensure that New York racing remains the best in the world, and to generate added economic benefits to the state and local communities."

NYRA Not on the FNYR Roster...

The New York Racing Association, which has run racing in the state since the mid '50s, was not involved in the founding of the new organization. "Officially, we have nothing to do with it," outgoing NYRA Chairman Barry Schwartz told *The Blood-Horse*. "NYRA has not been a part of the discussions." But he added that, in order for FNYR to succeed, it would need to give NYRA at least an "arms-length" role. NYRA has had more than its share of legal problems, including an investigation that led to last year's convictions of more than a dozen NYRA employees on charges of money laundering and tax fraud. More trouble arose Wednesday when all three NYRA tracks--Aqueduct, Belmont Park and Saratoga--were raided, possibly to look into allegations surrounding the procedures used to weigh jockeys prior to races. NYRA's current charter ends on Dec. 31, 2007. While officials insisted that FNYR was not put together to go after the franchise, several members could be involved in the bidding process. Both Churchill Downs, Inc. and Magna Entertainment have expressed interest in the NYRA franchise in the past.

HARD BUCK TO CLOVERLEAF FARMS World-traveling Grade I winner **Hard Buck (Brz)** (Spend a Buck --Social Secret {GB}, by Secreto) will begin his stud career next season at Cloverleaf Farms II in Reddick, Florida. The five-year-old, a Group 1 winner in his native Brazil, captured this year's GI Gulfstream Park Breeders' Cup H. and was second in the G1 Dubai Sheema Classic and in the G1 King George VI and Queen Elizabeth Diamond S. On the board in 14 of 19 starts, Hard Buck won nine times and earned \$1,073,674. He will stand for \$2,500.

Bob Flynn Named NYRA Trustee:

Bob Flynn, the executive director of the New York Thoroughbred Horsemen's Association, has been named to the Board of Trustees of the New York Racing Association. The nomination will now be sent to the New York Racing and Wagering Board for approval. A New York City native, Flynn graduated from Fordham University with an MBA in finance. He worked for NYRA for 18 years, including a six-year stint as assistant racing secretary, before joining the New York Horsemen's Benevolent and Protective Association, forerunner of the NYTHA, as executive director in 1994. "I am happy and honored to be named to the Board," Flynn said. "I think this is going to be very positive for all concerned--for NYRA, for the horsemen and for myself, especially in terms of communication with all aspects of our industry."
